CHRONOLOGY OF RECENT EVENTS VANCOUVER POLICE AND NATIVE LIAISON SOCIETY

- Sent out initial funding renewal package January 2003
- George Brown requested a meeting with VSD March 27, 2003
- Response to funding renewal package received February 2003
- Information provided in funding renewal package not acceptable, message conveyed to program that board needed to be involved in this process not program solely
- Advised by ED on April 10, 2003 of an alleged breach of confidentiality which
 came to her attention in a letter to program dated February 17, 2003, this has
 resulted in considerable discord between ED and board as to how this matter should
 be addressed. The letter of complaint had also been forwarded to the Chief, VPD.
- Board members resigning, unsure if sufficient numbers left to constitute a board
- VSD called meeting with Board and VPD on April 4, 2003 attending were Edna, Olive, and Bob Rich of VPD
- Following that meeting met with all staff and re-iterated role of board, role of ED
- Agreement that those three constituted Board, needed to restore what had been lost over the issue of breach, board agreed that restorative justice healing circle should occur
- Due to present situation with reference to the existence of Board, VSD determined that to give them time to regroup we would provide three month interim funding, await a new funding renewal submission and re-assess at that time. Interim funding contract signed April 4, 2003 (Edna/Olive)
- In consultation with Board, VSD made arrangements for facilitator, location, etc for circle, dated set May 2, 2003
- May 2, 2003 VSD received a call from Bob Rich (VPD) that he along with five
 other staff were at the circle location but no facilitator was present. VSD confirmed
 with facilitator that board had cancelled process but failed to advise any staff or
 VSD
- May 16, 2003, VSD received an email from Joy Ward advising that she was our board contact. She advised that a letter was being placed on Morris Bates file with reference to the breach of confidentiality and that VSD would be provided a copy within the next week.
- May 23, 2003 a second funding renewal package forwarded to Board for completion
- VSD's next contact from Board were copies of letters one dated May 27, 2003 terminated the ED; one dated May 30, 2003 requesting documentation from the terminated ED, two letters dated June 3, 2003 requested the terminated ED and a victim service worker (who had recently resigned) requesting these two people to contact the society re a secondment opportunity.
