Played her tape line-up, instructed her to tell me if she recognised any of the voices on the tape.

She did not recognise any of the voices on the tape.

I then explained to her I was there to discuss Willy PICKTON's assault on her and to ask her what she recalled, if anything, from that night. She then stated that if PICKTON'S voice were one of the ones on the tape, she wouldn't know for sure. She said she couldn't rule out one of the voices could be his, but her recall of his voice wasn't very good.

She stated PICKTON picked her up early evening 970322 at the bus stop on the southeast corner of Princess and Cordova streets in Vancouver. She stated PICKTON was driving a red pickup truck and seemed quite comfortable picking up prostitutes and did not seem that this was new to him and she didn't sense any nervousness on his part. She recalls he told her he tended to come down there and pick up women every second Friday night. His hair was scraggly and he had a dirty blonde growth of beard. There was a white bra in the truck she initially forgot seeing and did not ask PICKTON anything about it. Later, when asked if this was her's by Coq RCMP, she said no because she did not wear one and then recalled the white one being in the truck. She could not recall seeing any women's clothing at PICKTON's residence on Dominion in Coq, nor does she recall seeing any women's identification.

She said when she and PICKTON were driving east along Lougheed Hwy she asked to use the washroom at a PetroCan station on a corner where there was an intersection and a red light. She noticed PICKTON slowed the truck several hundreds metres from the light to time it so that by the time they reached the intersection the light would be green and [REDACTED] felt in retrospect this was a deliberate attempt to eliminate any chance of her getting out the vehicle.

Another thing which struck her as odd was when they arrived at PICKTON'S trailer in Coq, he stopped her as they were walking from the truck to the trailer and after she walked across a gravel walk, he made her wait while he laid down a piece of plywood over a dirt portion that goes from the end of the gravel to the door of the trailer. She felt he did not want her to walk on the dirt so as not to leave marks on it. I asked her if it was possible it was wet or raining and PICKTON just didn't want them to track in mud, but she could not recall. She felt if it was about making a mess in the trailer, the plywood would be down permanently and not need to be moved into place by PICKTON. She recalls thinking his behaviour with regard to this was strange.

I have left it with her to try to find out from any street girls she may know if anyone has seen PICKTON in the area before or since her incident. She was very cooperative and

struck me as quite credible and very afraid of PICKTON. Her biggest concern was him finding her somehow.
