**MISSING WOMEN COMMISSION OF INQUIRY**

**AFFIDAVIT OF DOUGLAS FELL**

I, Douglas FELL, Detective Constable with the Vancouver Police Department, 2120 Cambie St, in the City of Vancouver, of the Province of British Columbia, **MAKE OATH AND SAY AS FOLLOWS:**

1. I am a police officer with the Vancouver Police Department, and as such have personal knowledge of the facts set out below.
2. This Affidavit is sworn in response to questions posed to me in writing by the Attorney General of Canada. The questions, but not the attachments referred to in the questions, are attached to this affidavit as Exhibit "A."
3. In response to the questions under the topic, "Photograph canvass conducted April 5 and 12, 2000," I have reviewed my notes and those of Mr. Wolthers, and agree that four (4) STWs identified Pickton.
4. I believe I did advise the MWRT about the picks on PICKTON. I believe I did so orally, rather than in writing. We provided our notes when we left in mid-May, 2000, so if anyone was interested in following up what I said orally, they could have asked me or looked at my notes.
5. In response to the questions under the topic "Adding Angela Arsenault to the VPD's list of missing women", I no longer have access to this tip file and I have no independent recollection of this file. I do not recall any conversations with Cst. Greg Armstrong or Mr. Doug Kennedy.
6. I did retain the tip 223 lead sheet which was entitled "Doug KENNEDY". I learned from this tip lead sheet provided to me that Mr. Kennedy is Angela Arsenault's father. The file was concluded pending new information on September 16, 1999 (see Commission Exhibit 175 NR, Tab 10, p. 14).

**TOPIC: Photograph canvass conducted April 5 and 12, 2000**

Please refer to your notes of April 5 and 12, 2000, marked at the Inquiry proceedings as Exhibit 174, Tab 9, pages 90-91, and 98-99. A copy of those notes is attached to this list of questions.

Is it true that, on April 5, 2000, you showed a photograph of Robert Pickton to a sex trade worker in Vancouver's Downtown Eastside, and that the sex trade worker (Desjarlais) identified Robert Pickton in that photograph?

If not, please explain why not.

Is it true that, on April 12, 2000, the image of Robert Pickton was identified by two sex trade workers (Yunker and STW16552) in the Downtown Eastside, neither of whom was the sex trade worker you referred to in your notes of April 5 and 12, 2000?

If not, please explain why not.

Please cross-reference your notes with the notes of your partner, Detective Mark Wolthers, dated April 12, 2000. These notes are marked as Exhibit 174, Tab 10, page 28. A copy of these notes is attached to this list of questions.

Is it true that, on April 12, 2000, the image of Robert Pickton was identified by a sex trade worker in the Downtown Eastside (STW8901), who was not one of the sex trade workers you referred to in your notes of April 5 and 12, 2000?

If not, please explain why not.

Would you agree that, based upon the notes made by you and your partner Det. Fell between April 5 and 12, 2000, a total of no less than 4 sex trade workers (Desjarlais, Yunker, STW 16552, and STW 8901) from the Downtown Eastside identified Robert Pickton when shown a photograph of him?

Do you recall providing the above information, or any of it, to other members of the Vancouver Police Department, in the period from January 3, 1997 to February 4, 2002?

If so, please give the names of the persons you provided this information to, and the dates, or approximate dates, when you communicated this information to them?

Please also provide the means by which you communicated this information.

**Do you recall communicating to the RCMP that the name of Angela Arsenault would be added to the Missing Women Review Team's list of missing women?**

**If so, who did you speak to, and when did the conversation occur?**

**Do you recall speaking with Constable Greg Armstrong of the Burnaby RCMP on September 15, 1999?**

**Do you recall informing him that you were in the process of getting Ms. Arsenault added to the VPD's list of missing STWs?**

**Can you recall taking any steps to add Ms. Arsenault's name to the MWRT's list of missing women?**
