In the course of re-reviewing my affidavit sworn April 27, 2012, I noted the following typographical errors and omissions:



2. Paragraph 184 contains a typo. The date shown as June 27 should read June 28.
3. Paragraph 200 contains a typo. The date shown as August 27 should read August 28.
4. Paragraph 202 contains a typo. The date shown as January 17 should read January 11.
5. Paragraph 296 was omitted. It should read:

I am advised by a review of Document EV3805, page 9, and do believe that on November 25, 2001, Constable Williams, of Project Evenhanded, attended a meeting between police and families, and met **CI-PERS** had a picture of Jacqueline and a binder of personal papers. Constable Williams stated that the photo and personal papers would be copied and returned.

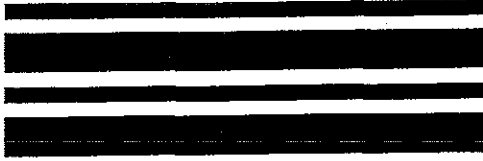

Extensive investigation has been conducted by VPD and White Rock Det members. All data bases have been checked, posters and photos have been distributed with negative results.

The coroner's office, the Dept of Indian Affairs, and Vital statistics for the provinces of Canada and Wash State have been checked all with negative results. Her dental records have been added to CPIC, her alias' include Lynn CHAPPELL and Sharra-Lynn CHAPPELL. She has no Social Insurance Number.

WILLIAMS ex boyfriend/pimp, **CI-PERS** B **PID** may still be in custody in Ont, he needs to be interviewed, all indications on file are he was the last person to see WILLIAMS.

A further indices check should be conducted with police and other agencies.
